

#### **PAG/RTA Committee Structure**

The governing bodies of Pima Association of Governments and the Regional Transportation Authority are, respectively, the PAG Regional Council and RTA Board. The Executive Director reports to the PAG Regional Council and RTA Board. Standing technical committees and ad hoc technical subcommittees report through the committee structure to the Management Committee – PAG's policy advisory committee. The Management Committee reports to the Executive Director.

The Executive Director is the chief administrator of PAG and the RTA and is responsible for day-to-day operations, including planning and preparation of all meeting agendas, including those of the RTA's special committees and advisory bodies (collectively "Committees"). The Executive Director will coordinate all activities of the PAG Regional Council, RTA Board and Committees to successfully facilitate and meet PAG's mission and RTA goals.

#### **Committee Roles and Responsibilities**

The responsibility of committee members is to assist with regional planning and/or document development or review in compliance with federal and state legal or contractual requirements and approved PAG/RTA policies using an open and respectful process.

The PAG Regional Council and RTA Board, including all their affiliated advisory Committees, are not authorized to conduct PAG or RTA administrative duties. Administrative duties are the sole responsibility of PAG's professional staff. Individual committee members shall not direct or in any manner take part in the administration of PAG/RTA operations.

All programs of PAG are grant-funded, contracted services, and PAG must comply with the terms and conditions of each contract. PAG staff is responsible for financial management and contract compliance and oversight. This is the nonprofit business environment in which PAG operates.

#### **Committee Fact Sheets**

Committee Fact Sheets identify members of the PAG Regional Council, Management Committee, standing technical committees and ad hoc technical subcommittees, as well as the RTA Board, citizen oversight and advisory committees, and technical subcommittees.

Updates to the PAG/RTA Committee Fact Sheets are completed annually. Additional updates may be completed throughout the year to reflect changes in the membership or specific committee characteristics.

PAG's Committee Operating Guidelines will be provided to new chairpersons.

# **Air Quality Subcommittee**



Type: Ad Hoc Technical Subcommittee

**Purpose:** To evaluate regional compliance issues relating to the 1977 Clean Air Act. Reviews and makes recommendations about air quality plans and proposals, such as non-attainment and maintenance area plans. Identify air-related priorities and provide guidance on these issues to EPAC.
