#### 1. Call to Order and Introductions

Vice Chair Jose Rodriguez called the meeting to order at 9:05 a.m., and introductions were made.

### 2. In-kind Reporting

PAG Transportation Planning Director Jeanette DeRenne informed the participants of the inkind form. Ms. DeRenne indicated that time spent on the meeting from members attending via Zoom will be recorded from the Zoom attendance report.

### 3. Approval of the Sept. 20, 2023, Meeting Summary

Video Timestamp: 7:09

**Action:** A motion to approve the Sept. 20, 2023, meeting summary was made by Thomas Garcia, Town of Sahuarita, seconded by Kathryn Skinner, Pima County, and passed unanimously.

# 4. Regional Transportation Revenues

### Video Timestamp: 7:58

RTA Budget Coordinator James Towe reported on the Regional Transportation Revenues update, including changes, expectations, and current trends. The Regional Transportation Revenues report now includes Vehicle License Tax (VLT), Local HURF, HURF 12.6, HURF 2.6, ASTBG, and STBG funding.

Mr. Towe explained the report to the members, and clarified questions on Table 1. Members were also informed of the following:

- HURF and VLT collections across the region are just shy of \$30 million as of August 2023. Of the \$30M PAG collected, about \$6.3M (about 20%) was regional funds. The remainder was distributed directly to member jurisdictions.
- HURF 12.6% is at \$5,182,931 which is 9.28% higher than the ADOT official forecast and is 7% higher than the year before.
- HURF 2.6% is at \$1,120,292 which is also higher than the ADOT official forecast.
- Currently \$30.2 million is collected in TPT, which is a 5% higher gain than the adopted budget.

# 5. Regional Mobility and Accessibility Plan (RMAP) Update

# Video Timestamp: 18:32

PAG Planning Coordinator Hannah Oden updated the members on the status of the list of transportation projects submitted, including a review of the current project costs compared to the fiscal constraints. A total of 382 projects were included in the list, which amounts to \$28.4 billion in costs. This is \$12.3 billion over the anticipated 2055 RMAP fiscal constraint. Members were asked to review the current reserve list and provide feedback on possible refinement of the reserve list.

Thomas Garcia, Town of Sahuarita, inquired how projects with multiple sponsors will be approached in terms of jurisdictional leadership. Jose Rodriguez, Town of Oro Valley, added that the Town has projects that include multiple sponsors. They are waiting for the RTA Next project list to decide how those projects will be handled. PAG Transportation Planning Director Jenette DeRenne informed the members that it will be necessary to circle back to these projects when the RTA Board has approved the RTA Next project list.

Kathryn Skinner, Pima County, requested an RMAP working group to further review the constraints and priorities of the project lint. She made that request in the form of a motion.

**Action:** A motion to create an RMAP Working Group was made by Kathryn Skinner, Pima County, seconded by Thomas Garcia, Town of Sahuarita, and passed unanimously.

Senior Transportation Planner David Mitchell provided an update on the recommended Performance Targets for the 2055 RMAP. PAG staff recommends extending all performance measures from the 2045 RMAP target except for Environmental Stewardship. For Environmental Stewardship, it is recommended to reduce current levels. PAG Modeling Administrator Hyunsoo Noh presented the 2022 County and Subcounty Population Projections, including the background of the projects and the RMAP timeline. Members were informed of the following:

- County population is projected to be 1,277,075 by 2055.
- Subcounty population is projected to be 1,276,988 by 2055.
- There is a 0.78% combined growth rate across Marana, Oro Valley, Sahuarita, South Tucson, Tucson, and Pima County.

# REQUESTED ACTION/SUGGESTED MOTION

The Transportation Planning Committee (TPC) will be asked to recommend approval of an amendment to the PAG FY 2022-FY 2026 Transportation Improvement Program (TIP), which would adjust the programming of Arizona Department of Transportation (ADOT) funds, known as ASTBG funds, on major ADOT projects.

### ASSOCIATED OWP WORK ELEMENT/GOAL

Work Element 40: Transportation Activities

### SUMMARY

As the region's designated metropolitan planning organization (MPO), PAG is responsible for maintaining the Transportation Improvement Program (TIP), including processing amendments to the FY 2022-FY 2026 TIP. This task includes the programming of Arizona State Department of Transportation (ADOT) funds that are to be spent on ADOT projects in PAG's planning area. These funds are primarily federal funds that are referred to in the TIP as ASTBG, with funding allocation amounts determined through the ADOT Resource Allocation Advisory Committee (RAAC). The funding allocation is then programmed on the state highway system in the PAG TIP in partnership with the ADOT Multimodal Planning Division (MPD) and the South-Central District.

ADOT has requested a formal TIP amendment to program the full funding of I-10: Country Club Rd. and Kino Interchanges (TIP ID 9.23) in the PAG FY 2022-FY 2026 TIP, which is necessary for the project to proceed to the next stage of implementation. To fully fund TIP ID 9.23 and remain fiscally constrained, this request also includes programming changes to the following projects: Barraza-Aviation Pkwy Extension (TIP ID 87.06), I-19: Irvington TI (TIP (ID 38.13), I-10: Park Ave. TI Ramp Reconstruction (TIP ID 6.23), I-10: 6th Ave. TI Bridge Widening (TIP ID 7.23) and I-19: Valencia Rd. to I-10 (TIP ID 8.23) as shown in the attached TIP amendment tables. Please see the attached TIP Amendment Request from ADOT for additional information.

#### PRIOR BOARD AND/OR COMMITTEE ACTION

The TIP Subcommittee approved this TIP amendment at the Oct. 31, 2023, meeting.

# TECHNICAL, POLICY, LEGAL OR OTHER CONSIDERATIONS

- PAG tracks the state gas tax revenue portion of Local HURF (sometimes called Direct HURF) and the Vehicle License Tax (VLT). This is used to report to our member jurisdictions, on a regionwide level, to compare with actual distributions.
- In addition to HURF allocations, the region receives federal funding through the Surface Transportation Block Grant Program (STBG). These funds are apportioned on an annual basis, and the amount is set by federal law in the most recent transportation authorization bill.
- In addition to regional HURF and STBG, ADOT funds spent in the greater Tucson region consist of both HURF and federal funds and are referred to as "ASTBG" funds in the PAG Transportation Improvement Program. PAG works cooperatively with ADOT to program 13% of ASTBG funds on projects in the greater Tucson planning area.

# **Regional Transportation Revenues Report**

This report showcases regional funding for roadway projects administered by Pima Association of Governments including Surface Transportation Block Grant (SBTG) Program funding, Highway User Revenue Funding (HURF) 12.6% and 2.6%, and Regional Transportation Authority (RTA) Excise Tax Revenues. Furthermore, HURF provided to local jurisdictions is also shown as a courtesy.

STBG funding is suballocated to urban areas based on population. PAG's largest source of STBG funding is known as "STBG > 200k" or STBG suballocated to urban areas exceeding 200,000 which includes portions of each of the following: the City of Tucson, the City of South Tucson, the Town of Marana, the Town of Oro Valley, portions of unincorporated Pima County, the San Xavier District of the Tohono O'odham Nation, and the Pascua Yaqui Pueblo. Apportionments for STBG > 200k are shown below.


