1. Call to Order

The meeting was called to order at 8:49 a.m.

2. Approval of March 12, 2025, Meeting Summary

Motion was made by Terry Rozema, Town of Marana, seconded by Jan Leshner, Pima County, and unanimously carried that the Management Committee of Pima Association of Governments approve the meeting summary of March 12, 2025.

3. Update on the development of Pima Association of Governments' (PAG's) FY 2026 and FY 2027 Overall Work Program (OWP)

PAG Program and Policy Coordinator Adam Ledford provided the Management Committee with an update on the development of the draft FY 2026 and FY 2027 Overall Work Program which consists of the scope of work for a grant agreement between PAG and ADOT on behalf of the federal agencies providing grants to PAG for 24 months beginning on July 1, 2025. Mr. Ledford also noted that a review of the

draft OWP was conducted by the Arizona Department of Transportation (ADOT), Federal Highways Administration (FHWA) and Federal Transit Administration (FTA). Based on that review, their comments indicate that PAG's OWP will be in compliance with federal requirements.

Mr. Ledford detailed the OWP document on items including how it is organized into general categories for the 15 work elements, such as transportation activities and RTA support.

Following the report by Mr. Ledford, the Management Committee did not have any questions or comments regarding this item and no action was required.

4. Regional Mobility and Accessibility Plan (RMAP) Update

PAG Transportation Planning Director Jeanette DeRenne provided the Management Committee with an update on the development of the 2055 RMAP, which is PAG's federally required long-range transportation plan. The report included details of an activity-based model for GIS modeling and performance reports, the approved financial plan and recent feedback from the RMAP Working Group. Ms. DeRenne noted that the draft plan will be shared with TPC at its next meeting, followed by a 30-day public comment period and anticipates Regional Council approval in July 2025.

The Management Committee did not have any questions or comments regarding this item, and no action was required.

5. Regional Transportation Revenues Update

PAG Budget Manager James Towe provided the Management Committee with a report on regional transportation revenue information and a summary of year-to-date FY 2024-2025 regionwide Highway User Revenue Fund (HURF) revenues. Mr. Towe detailed the financial tables within the meeting materials provided to the committee.

The Management Committee did not have any questions or comments regarding this item, and no action was required.
