A representative of the University of Arizona will share information about a Tri-University effort with the Arizona Department of Water Resources to increase water supplies for communities and support ecosystems through assessing best locations and methods for capturing precipitation and replenishing aquifers.

5. Areawide Water Quality Management Plan Updates

PAG staff will also provide an annual summary of technical updates to the PAG 208 Plan, describe the process to update the wastewater facility inventory and flow projections, and call for any new water quality issue data and management accomplishments that may be added to the 5-year comprehensive compilation of edits.
